A scheduled Regular Meeting of the Borough Council of the Borough of Medford Lakes, New Jersey, beginning at 7:00pm was held in-person following the pledge of allegiance and a moment of silence (Council and the public observed a moment of silence to honor service men and women defending our country). Clerk McIntosh read the Open Public Meetings Act: pursuant to the requirements of the Open Public Meetings Act, adequate notice of this scheduled regular meeting has been published in the Burlington County Times and posted on the official bulletin board of the Borough of Medford Lakes. Those wishing to be notified of changes to scheduled meetings were notified via email or regular mail.

ORDINANCE NUMBER 729

**AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 145-35 OF THE CODE OF
THE BOROUGH OF MEDFORD LAKES ENTITLED 'LAKES COMMERCIAL'**

WHEREAS, the Borough Council of the Borough of Medford Lakes ("Borough") recognizes the need to modernize its zoning code to reflect evolving residential and mixed-use needs within the Lakes Commercial Zone; and

WHEREAS, the Borough currently restricts residential dwellings within commercial structures to only owners or operators, which is no longer consistent with modern land use planning and law and

WHEREAS, the Borough Council wishes to revise Section 145-35(B)(6) to permit second-floor residential apartments over commercial uses, with a minimum of 850 square feet of living space, excluding any common areas.

NOW, THEREFORE, BE IT HEREBY ORDAINED by the Borough Council of the Borough of Medford Lakes, County of Burlington, State of New Jersey, as follows:

Section 1. Chapter 145-35(B)(6) of the Code of the Borough of Medford Lakes is hereby amended as follows:

§ 145-35 Lakes Commercial.

B. Permitted uses.

(6) Dwelling quarters for owners or operators in the same building as the commercial use, and must contain not less than 850 square feet of living space.

(6) Residential dwelling units located exclusively on the second floor of a structure with a permitted ground-floor commercial use, and must contain not less than 850 square feet of living space, excluding common areas.

Section 2. Repealer.

All Ordinances or parts of Ordinances inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

Section 3. Severability.

If any section, subsection, paragraph, sentence, clause, or phrase of this Ordinance shall be declared invalid or unenforceable for any reason, then the Borough Council hereby declares its intent that the remaining portions of the Ordinance shall remain in full force and effect, and for this purpose, the provisions of the Ordinance are hereby to be severable.

Section 4. Effective Date.

Solicitor Heinold explained that this ordinance will address the outdated language of assuming “the shop keeper lives above the shop.” This ordinance will make the Borough consistent with the law and prevent any issues or confusion going forward.

Clerk McIntosh stated that Planning Board Attorney Kingsbury sent a letter confirming that the Planning Board reviewed the draft ordinance and agreed it was not inconsistent with the Master Plan of the Borough. Council will review this letter in the communications portion of the meeting.

Mayor Fields verified with the Clerk that second reading and public comment for this ordinance would be at the January 28th Regular Council meeting and he called for the vote.

**A RESOLUTION APPOINTING THE BOROUGH CLERK AS
AMERICANS WITH DISABILITIES COORDINATOR**

WHEREAS, every municipality is required to designate an ADA Coordinator; and

WHEREAS, the ADA Coordinator's role is to ensure compliance with the Americans with Disabilities Act.

NOW THEREFORE BE IT RESOLVED, by the Borough Council of the Borough of Medford Lakes, County of Burlington, State of New Jersey hereby appoints the Borough Clerk as ADA Coordinator for the Borough of Medford Lakes for year 2026.

BE IT FURTHER RESOLVED, that this Resolution shall take effect immediately upon adoption according to law.

RESOLUTION NUMBER 2-26

A RESOLUTION AUTHORIZING THE TAX COLLECTOR TO CANCEL 2025 PROPERTY TAX AND SEWER FEES OF DELINQUENT AMOUNTS LESS THAN \$10.00

WHEREAS, N.J.S.A. 40A:5-17 allows for the cancellation of property tax overpayments or delinquent amounts in the amounts of less than \$10.00; and

WHEREAS, the governing body of the Borough of Medford Lakes may authorize the Tax Collector to process, without further action on their part, any cancellation of property tax overpayments or delinquencies of less than \$10.00.

THEREFORE, BE IT RESOLVED, by the Borough Council of the Borough of Medford Lakes, County of Burlington, State of New Jersey, hereby authorizes the Tax Collector to cancel said tax amounts as deemed necessary.

BE IT FURTHER RESOLVED, that a certified copy of the Resolution be forwarded to the Tax Collector, the Chief Financial Officer and the Municipal Auditor.

RESOLUTION NUMBER 3-26

A RESOLUTION NAMING OFFICIAL DEPOSITORIES FOR THE BOROUGH OF MEDFORD LAKES FOR THE YEAR 2026

WHEREAS, N.J.S.A 40A: 5-14 mandates that the Governing Body of a Municipal Corporation shall, by resolution passed by a majority vote of the full membership thereof, designate as a depository for its monies a bank or trust company having its place of business in the State and organized under laws of the United States;

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of Medford Lakes, New Jersey that, any financial institution or bank that is licensed to do business in the State of New Jersey and is covered by the GOVERNMENT UNIT DEPOSIT PROTECTION ACT, and the New Jersey

Cash Management Fund, be and are, hereby designated as official depositories for Borough funds. Prior to the deposit of any Municipal funds in the above-mentioned depositories said bank shall file with the Chief Financial Officer a statement indicating that the bank is covered.

**A RESOLUTION AUTHORIZING INVESTMENT OF IDLE FUNDS
AND FUND TRANSFERS**

WHEREAS, it is desirable that idle funds of the Borough of Medford Lakes be invested in legal investment vehicles at all times; and

WHEREAS, it is occasionally necessary to transfer funds for the purpose of meeting current Borough expenses or for the purpose of effecting investments;

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of Medford Lakes, New Jersey that it does hereby authorize the Chief Financial Officer to request bids and to place orders for the investment of idle funds solely in legally authorized investment vehicles such as investments to the investing institution; and

BE IT FURTHER RESOLVED by the Borough Council of the Borough of Medford Lakes that it does authorize the Chief Financial Officer to transfer funds by wire solely for the following purposes and subject to all pertinent regulations:

1. To or from Borough checking or savings accounts to other Borough accounts;
2. To or from Borough checking or savings accounts to other Borough accounts specified by banks or the State of New Jersey Cash Management Funds solely for the purpose of investing for the account of the Borough of Medford Lakes, New Jersey.

WHEREAS, N.J.A.C. 17:27-1.1 provides that no public work contracts can be awarded nor any monies paid until the prospective contractor has agreed to contract performance which complies with an approved affirmative action program; and

WHEREAS, N.J.A.C. 17:27-3.5 provides that each public agency shall annually designate an officer or employee to serve as its public agency compliance officer;

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of Medford Lakes, County of Burlington, State of New Jersey hereby appoints the Borough Clerk as the Public Agency Compliance Officer for a one-year term ending December 31, 2026.

**A RESOLUTION AUTHORIZING THE RE-
ESTABLISHMENT OF A PETTY CASH FUND**

WHEREAS, N.J.S.A.40A: 5-21 authorizes the establishment of a Petty Cash Fund for the Clerk's Office of the Borough of Medford Lakes to be used by such office or department to pay claims for small miscellaneous expenses; and

WHEREAS, said Petty Cash Fund was established by Resolution dated June 8, 1972 by the Borough Council of the Borough of Medford Lakes; and

WHEREAS, it is the desire of the Borough Council that said fund be continued under direction of the Clerk; and

WHEREAS, by order of the Administrative Office of the Courts of the State of New Jersey, Rule 7:7-8 (e) the Medford Lakes Borough Court is required to pay subpoenaed witnesses a \$2.00 fee when called to testify on behalf of the State or on behalf of indigent defendants.

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of Medford Lakes, New Jersey, that:

1. During the year 2026 the Borough Clerk be and is hereby authorized and permitted to establish a Petty Cash Fund in the amount not to exceed \$220.00 pursuant to the provisions of N.J.S.A 40A: 5-21. Said Petty Cash Fund will be used by such office or department to pay claims for small miscellaneous expenses and witness fees as determined by the Medford Lakes Borough Court.

2. The Borough Clerk, having custody of the Fund be bonded in an amount not less than \$1,000.00 and will maintain said Fund in accordance with the laws and regulations governing its operation.

RESOLUTION NUMBER 8-26

A RESOLUTION AUTHORIZING SIGNATURES ON BOROUGH BANK ACCOUNTS

WHEREAS, it is the desire of the Borough Council of the Borough of Medford Lakes to designate certain Borough Officials as signatories for Borough Bank Accounts.

NOW, THEREFORE, BE IT RESOLVED, by the Borough Council of the Borough of Medford Lakes, New Jersey that the following Borough Officials are hereby authorized to sign checks or withdrawal slips:

- A. The following bank accounts of the Borough of Medford Lakes shall require two (2) signatures as follows: First Signature shall be that of the Mayor. In the absence of the Mayor, a Borough Councilperson shall sign. Second signature shall be that of the Chief Financial Officer. In the absence of the Chief Financial Officer, the Municipal Clerk shall sign. In the absence of the Chief Financial Officer and the Municipal Clerk, the Borough Manager or the Tax Collector shall sign.

Accounts: Current Fund, General Capital Fund, Wastewater, Wastewater Capital, Police Body Armor, Environmental, Street Opening, Planning and Zoning, Animal Control, Municipal Alliance, Flood Relief, Public Defender, Unemployment, Special Law Enforcement,

- B. The payroll account of the Borough of Medford Lakes shall require two (2) signatures from the following officers: Chief Financial Officer, the Borough Clerk, Borough Manager or Tax Collector.
- C. The Tax Title Lien Account of the Borough of Medford Lakes shall require two (2) signatures as following: Signature number one shall be that of the Tax Collector. Signature number two shall be that of the Chief Financial Officer. In the absence of the Chief Financial Officer, the Municipal Clerk shall sign. In the absence of the Chief Financial Officer and the Municipal Clerk, the Borough Manager shall sign.
- D. The Municipal Court Account and Municipal Court Bail Account of the Borough of Medford Lakes shall require the signature of the Court Administrator. In the absence of the Court Administrator, the Deputy Court Administrator or Municipal Court Judge shall sign.
- E. Any Bank Account not listed in this resolution shall require the signatures as listed in "A" above unless a Resolution of the Governing Body is adopted.

RESOLUTION NUMBER 9-26

**A RESOLUTION ADOPTING RULES AND REGULATIONS
REGARDING THE IMPLEMENTATION OF ANIMAL LICENSING FEES**

WHEREAS, Ordinance No. 478, as amended, at Section 9, provides that rules and regulations may be imposed by Resolution; and

WHEREAS, any Animal Control Services (ACS) outside of normal licensing shall be charged to the animal owner payable to the Borough of Medford Lakes in accordance with the annual ACS contract; and

WHEREAS, a licensing late charge shall be due and payable for dogs and cats that are owned prior to January 31, 2026, annually, thirty (30) days after such date. For dogs and cats that are acquired after January 31, 2026, the late charge shall be due and payable thirty (30) days after the licensing is required pursuant to the Borough Code Chapter 70.

THEREFORE, BE IT RESOLVED, by the Borough Council of the Borough of Medford Lakes, County of Burlington, State of New Jersey, that the licensing fees as defined in the Borough Code Chapter 112 shall be in effect until further notice.

RESOLUTION NUMBER 10-26

**A RESOLUTION ESTABLISHING A GRACE PERIOD FOR PAYMENT OF TAXES AND
SETTING THE RATE OF INTEREST ON DELINQUENT TAXES FOR THE YEAR 2026 AND
ESTABLISHING MISCELLANEOUS CHARGES**

WHEREAS, the Borough of Medford Lakes has determined that it is desirable for taxpayer to be permitted a grace period for the payment of taxes; and

WHEREAS, R.S. 54:4-67 provides that the Governing Body may establish a grace period and fix the rate of interest to be charged; and

NOW, THEREFORE, BE IT RESOLVED, by the Borough Council of the Borough of Medford Lakes, County of Burlington, State of New Jersey, that no interest shall be charged on taxes which are paid within ten (10) days of the date on which they become due, but interest shall be paid from the date due on all taxes which are paid more than ten (10) days after they become due; and

BE IT FURTHER RESOLVED, that the rate of interest on delinquent taxes and delinquent assessments shall be eight percent (8%) per annum for the year 2026 except when the total delinquency exceeds \$1,500.00, the interest rate shall be eighteen percent (18%) per annum on the portion in excess of \$1,500.00 and shall remain at eighteen percent (18%) (even if the amount is below \$1,500.00) until the account becomes current; and

BE IT FURTHER RESOLVED, that an additional penalty of six percent (6%) of the amount of the delinquency in excess of \$10,000.00 including taxes, assessments and sewer charges be charged to a taxpayer who fails to pay the delinquency prior to the end of the fiscal year.

BE IT FURTHER RESOLVED, that a charge of \$25.00 will be collected for the issuance of a Certificate of Redemption.

RESOLUTION NUMBER 11-26

A RESOLUTION ESTABLISHING A GRACE PERIOD FOR PAYMENT OF SEWER SERVICES AND SETTING THE RATE OF INTEREST ON DELINQUENT SEWER SERVICES FOR THE YEAR 2026

WHEREAS, the Borough of Medford Lakes has determined that it is desirable for taxpayer to be permitted a grace period for the payment of sewer services; and

WHEREAS, NJSA 40:14A-21 provides that the Governing Body may establish a grace period and fix the rate of interest to be charged; and

NOW, THEREFORE, BE IT RESOLVED, by the Borough Council of the Borough of Medford Lakes, County of Burlington, State of New Jersey, that no interest shall be charged on sewer services which are paid within ten (10) days of the date on which they become due, but interest shall be paid from the date due on all sewer services which are paid more than ten (10) days after they become due; and

BE IT FURTHER RESOLVED, that the rate of interest on delinquent sewer services shall be eighteen percent (18%) per annum for the year 2026; and

BE IT FURTHER RESOLVED, that an additional penalty of six percent (6%) of the amount of the delinquency in excess of \$10,000.000 including taxes, assessments and sewer charges be charged to a taxpayer who fails to pay the delinquency prior to the end of the fiscal year.

A RESOLUTION AUTHORIZING THE TAX COLLECTOR TO REFUND OR TO APPLY CREDITS FOR TAXES

WHEREAS, there are taxpayers of the Borough of Medford Lakes who are due to receive refunds with five percent (5%) interest resulting from judgments by the Burlington County Board of Taxation pursuant to N.J.S.A. 54:3-27.2.

NOW, THEREFORE, BE IT RESOLVED, by the Borough Council of the Borough of Medford Lakes, County of Burlington, State of New Jersey, that the Borough of Medford Lakes Tax Collector be

and hereby is authorized with the concurrence of the Chief Financial Officer to make such refunds or to apply such credits at their discretion.

BE IT FURTHER RESOLVED, that a copy of this resolution be forwarded to the Tax Collector and CFO for their records.

RESOLUTION NUMBER 13-26

**A RESOLUTION AUTHORIZING THE ISSUANCE OF
DUPLICATE TAX SALE CERTIFICATE PURSUANT TO CHAPTER 99 OF
THE PUBLIC LAWS OF 1997 AND SETTING A FEE**

WHEREAS, the Tax Collector of this municipality has previously issued a tax sale certificate covering a premises commonly known and referred to with a block and lot number as set out in the municipal tax map; and

WHEREAS, the purchaser of the aforesaid tax sale certificate has indicated to the Tax Collector that they have lost or otherwise misplaced the original tax sale certificate and have duly filed the appropriate Affidavit of Loss with the Tax Collector.

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of Medford Lakes, County of Burlington, State of New Jersey, that the Tax Collector of the municipality be and is hereby authorized, upon receipt of the appropriately executed and notarized Loss Affidavit and the payment of a fee of \$100.00 per certificate, to issue an appropriate duplicate tax sale certificate to the said purchaser covering the certificate lost as previously described all in accordance with the requirements of Chapter 99 of Public Laws of 1997.

BE IT FURTHER RESOLVED, that a copy of this resolution and the Loss Affidavit be attached to the duplicate certificate to be issued to said purchaser and that said duplicate certificate shall be stamped or otherwise have imprinted upon it the word "DUPLICATE" as required by law.

**A RESOLUTION ESTABLISHING A FEE FOR THE MAILING OF TAX NOTICES
IN LIEU OF ANY TWO PUBLICATIONS**

WHEREAS, N.J.S.A. 54:5-26 states that a notice of Tax Sale be published in a newspaper circulated within the municipality once in each of the four preceding calendar weeks prior to the week of the sale; and

WHEREAS, N.J.S.A. 54:5-26 allows in lieu of any two publications notice to the property owner, person or entity entitled by direct or certified mail is allowed; and

WHEREAS, the cost for such notice shall be added to the cost of the sale in addition to those provided in R.S. 54:5-38.

THEREFORE, BE IT RESOLVED, that the Borough Council of the Borough of Medford Lakes, County of Burlington, State of New Jersey hereby authorizes the Tax Collector to charge a \$25.00 fee for each set of notices mailed for a particular property pursuant to N.J.S.A. 54:5-26.

**A RESOLUTION CREATING A CHANGE FUND FOR THE POLICE
DEPARTMENT TO PROCESS REQUESTS FOR REPORTS**

WHEREAS, certain funds are collected by the Police Department for copies of police reports, accident reports, etc; and

WHEREAS, the Police Department needs a change fund on hand to make change when needed.

NOW, THEREFORE BE IT RESOLVED, by the Mayor and Council of the Borough of Medford Lakes that a change fund in the amount of \$50.00 is authorized to be used by the Borough Police Department.

RESOLUTION NUMBER 16-26

**A RESOLUTION OF THE BOROUGH OF MEDFORD LAKES, COUNTY OF BURLINGTON,
STATE OF NEW JERSEY AUTHORIZING THE CERTIFIED MUNICIPAL FINANCE
OFFICER (CMFO) TO PAY CERTAIN CLAIMS BETWEEN MEETINGS OF THE
GOVERNING BODY**

WHEREAS, N.J.S.A. 40A:5-17 provides that the governing body may, by resolution, designate one person who may approve claims between meetings of the governing body; and

WHEREAS, the Borough has specified the designee as the Certified Municipal Financial Officer (CFO) as the person authorized to pay these claims and present them to the governing body at its next meeting for ratification, except that, prior to being paid, such vouchers shall be brought to the attention of the CFO, Borough Manager and the Administration Committee of Borough Council for their approval; and

WHEREAS, in order for a claim to be paid a purchase order must be presented in accordance with the Purchasing Policy of the Borough of Medford Lakes and approved by the Certified Municipal Finance Officer, Borough Manager and the Administration Committee of Borough Council. The claim shall be paid by a check drawn on the municipality, signed by the authorized signers designated by Resolution of the Borough of Medford Lakes but in no instance shall a check be issued in this manner without one signature being that of a governing body member.

NOW, THEREFORE BE IT RESOLVED that the following claims may be processed and paid between meetings of the governing body:

1. Statutory payments
2. Utility payments
3. Insurance payments
4. Installment payments of authorized debt
5. Contractual payments as prescribed in an approved contract

WHEREAS, Statutory provision is made for the review and correction of errors prior to certification of an assessment list; and

REPORT(S)

Deputy Manager/Clerk McIntosh presented the managers' report as he is acting manager in Manager Burtons absence. He stated that Manager Burton has been working on the 2026 Municipal Budget preparation by gathering Budget and Capital requests from each department. He continues to work with the Colony Executive Board to communicate in accordance with the Boroughs shared service agreement. The Borough is working on the close out of 2025 files and necessary budget transfers. The system has been rolled over by the Boroughs CFO, and he stated that the State is now allowing municipalities that operate in the calendar year to rectify 35% of the temporary budget versus the 25.26% still required for municipalities that operate in the fiscal year.

Clerk McIntosh stated that his office is working to close out 2025 files and start 2026. The free rabies vaccine clinic will be held January 24th from 9a-12p.

Police Chief McGinnis stated that he will have a written report at the next meeting. His office has been extremely busy with several domestic violence calls, a fatal car accident and the third suicide in town in the short time since he became chief. He promoted the Burlington County hotline for mental health services. He is also working on the departments 2026 Budget.

Mayor Fields stated that he and Deputy Mayor O'Neill met with Colony representatives of the Women's Club to discuss plans for this year's Medford Lakes Day. Medford Lakes Day will be held the first Sunday in May as it has been in previous years.

COMMUNICATIONS

Clerk McIntosh presented Council with a letter from NJDOT informing Medford Lakes of a \$1,356,000.00 grant for the McKendimen Road Pedestrian Improvement

Clerk McIntosh presented Council with the letter discussed earlier in the meeting from Planning Board Attorney Robert E. PUBLIC COMMENT #2

Mayor Fields opened public comment.

1. Joe Aromando of Medford Lakes wants to make sure Council is aware that the Planning Board review of the proposed ordinance was completed in 2025, with the introduction happening in 2026 he feels this may be an issue.

Solicitor Heinold assured Mr. Aromando that there was no issue with the structure of this ordinance.

Mr. Aromando continued stating that he saw a Borough truck with an extended cab plowing snow on his street. He would like an explanation regarding the need for a truck with an extended cab. He also stated that he recently saw the “behemoth” of the new Vactor Truck and would like to know why we need such vehicle for such a small town. He feels that money is being needlessly spent “behind closed doors.” He feels that the Borough should begin having budget workshops as they have in the past. He would also like to know why there is still an Environmental Commission vacancy when he submitted his application several months ago. He stated that Land Use Ordinances are to protect health, safety and well-being of the community. With that in mind, he feels that the Borough Code Enforcement has been far too lax. He feels that applications that clearly go against existing ordinances are “pencil whipped” through the approval process. He feels that there are properties that are found to be in violation but “nothing is ever done about it.” He feels “there is no good reason to deviate from the rules.” He stated he is accustomed to the “Lou Potter days where if a resident was told to move their boulders and they weren’t moved by the end of the week, public works would come and take them.”

Hearing no further comment, Mayor Fields closed public comment.

Solicitor Heinold stated that the way Medford Lakes was designed over many decades and the result is “unique.” Other communities may have more modern subdivisions and very explicitly clear lines of demarcation on the right-of-way. From well before anyone currently sitting on Council was elected to Council there have been encroachments into the right-of-way. Some are obvious and some are not. The Borough faces issues as reasonably as possible on a case by case basis. The primary issue is always public safety, health and welfare. Around town there are absolutely several items in the right-of-way if you’re looking for them and have been for many years, however if the police, fire and engineering office don’t see an issue, it’s likely not an issue. If at any point the Borough needs to use the full right-of-way, there is no waiver in place for the structures or items in the right-of-way, the Borough retains the authority to address the issue.
